1 CALL TO ORDER

The meeting was called to order at 7:02 PM.

2 ROLL CALL

3 AGENDA APPROVAL

Commissioner McCormick moved to approve the agenda, seconded by Commissioner Anisimova. On a voice vote, the motion carried.

The commission discussed having one commissioner in attendance at City Council meetings, preparing a list of key points for Council Member Tooson's liaison report, and preparing a larger quarterly report for City Council.

- Commissioner Mohamed asked Chief Moore about changes to the monthly statistic reports and thanked the Ypsilanti Police Department for helping with school bus traffic issues in College Heights.
- Commissioner McCormick said she is pleased with increased police presence throughout the city.

- Commissioner Humes said he is pleased with increased police presence throughout the city.
- Commissioner Wolkoff reminded the commission that school starts soon so please be on the lookout for traffic issues.
